Dear Speaker Pelosi, Leaders Hoyer and McCarthy, and Minority Whip Scalise:

On behalf of United for Medical Research (UMR), which represents leading scientific research institutions and industries, and patient and health advocates, we thank you for your continued support of the National Institutes of Health (NIH) and urge you to enact a new budget agreement that would avert steep cuts in non-defense discretionary spending dictated by the 2011 Budget Control Act.

Fortunately for the past seven years, Congress has recognized how devastating the BCA cuts would be and has negotiated bipartisan agreements to provide critical funding for our nation's priorities. And thanks to Congress's commitment to the NIH, amazing medical advances are happening every day, touching the lives of many children and adults through NIH's discovery-driven research. These stories of triumph over disease are providing hope to millions of patients whose diseases and conditions await the next generation of treatments or cures. For the past four years, there has been a strong bipartisan effort in Congress to increase the NIH budget and ensure that the United States is investing properly in the health of its citizens and maintaining its competitive edge as a global leader in medical research. Pulling back now would harm this essential momentum.

NIH-funded research is an engine for medical and economic progress, and produces an exceptionally strong return on investment. Last year alone, NIH-funded research supported 433,000 jobs and \$74 billion in economic activity across the United States. Congress must renew its bipartisan commitment to this national treasure so we can continue advancements in research that will lead to cures and treatments for deadly diseases like cancer, heart disease, Alzheimer's and ALS.

To safeguard our nation's most important institutions, and to help keep America safe, healthy and competitive, we believe it's essential that Congress raise the budget caps equally between non-defense and defense programs.

UMR greatly appreciates your support over the last four years of placing NIH on a more sustainable growth path. Enacting a budget deal that raises the sequestration caps will ensure the gains from that critical investment continue to flourish.
